Report suspected and confirmed cases to the Infectious Disease Epidemiology Program at 802-863-7240 or 800-640-4374 (within Vermont only) 24/7 for immediately reportable diseases.

In addition to the list below, the following are immediately reportable:

- Any single unusual occurrence of a communicable disease of a major public health concern
- Any single unusual occurrence of a laboratory finding of a major public health concern
- Any unexpected pattern or cluster of cases, suspected cases, or deaths from a disease or laboratory finding of a major public health concern
